## 2022 FARMERS MARKET COMMUNITY FREE-SPACE APPLICATION

The 2022 Market runs each Tuesday from June 7 through September 27, 12pm – 6pm.

Community groups and/or organizations requesting a “FREE SPACE” reservation at the Crossroads Farmers Market must be a not-for-profit organization offering information regarding market-related and/or community services.

Free space reservations are in demand and requests may be limited to one Tuesday per market season on a first-come, first-served basis. Market Management will determine further availability as space permits.

To apply for a free space, please follow the instructions outlined below:

1. Complete and return this application form at least one month before date(s) requested. *Please note that spaces fill quickly for the entire season.* Your organization will receive a letter/email confirmation of reservation a few weeks before the requested date of participation.
2. You will either be required to bring your own pop-up tent with leg weights, or you will be assigned to a tent and provided table space and chairs. **Preference is for applicant to bring their own equipment and tent.**
3. Information may be distributed from the tent area only. No microphones, electronically enhanced presentations are permitted, without Market approval.
4. Free-space groups are subject to all Market Rules unless otherwise specified.
5. Failure to show up for your reserved time can result in not being invited back to participate in future Markets.
6. **You must stay for the entire Market period (12pm– 6pm). No exceptions.**
